## Dear parents and pupils

You may be aware that Weston-Super-Mare Town Council met this week to discuss a proposal to become a recognised "Council of Sanctuary." This initiative aims to make our town a welcoming and supportive place for everyone, including those who have sought refuge here.

Unfortunately, this discussion has attracted some negative attention and protests. There was a demonstration outside the Town Hall during the meeting, and there have been a number of critical comments on social media. This indicates that there are some within our community who hold strong feelings against this proposal.

NSC understands that expressions of prejudice and intolerance, even from a minority, can have a significant impact on individuals and the wider community, particularly within our schools. Such sentiments can create feelings of fear, anxiety, and exclusion, especially for those who may already be vulnerable. It is crucial that all our schools continue to uphold values of respect, empathy, inclusivity, and to provide safe and supportive learning environments.

We are writing to all schools to:

- 1. **Raise awareness:** Ensure that you are aware of the situation and its potential impact on your school community.
- 2. **Reiterate support:** Remind you of the support available from the Local Authority and other agencies.
- 3. **Encourage action:** Encourage proactive steps to address any concerns and promote understanding within your school.

## Support available for schools:

The reporting of hate incidents is important and encouraged but support is available to you whether you choose to report or not.


